CME COURSE TRAVEL GRANTS

RULES AND REGULATIONS

a) **WHAT THEY ARE.** The ERA-EDTA will give two travel grants of **EURO 500.00** for each CME Course to nephrologists that are less than 35 years old and early in their career, plus **one year ERA-EDTA membership** (including free access to NDT Online and the right to pay a reduced registration fee to the annual ERA-EDTA Congresses).

b) **WHO DOES THE SELECTION.** The local Course organisers will be in charge of deciding who will receive these Grants, with the only provision that the winner must not be older than 35 years of age. The names of the applicants will be sent to the local Course organisers by the ERA-EDTA Administrative Office by May 18, 2006. The local Course organisers must then send the names of the Winners to the ERA-EDTA Administrative Office within May 30, 2006.

c) **HOW TO REQUEST/RECEIVE THEM.** In order to request these Grant the applicants must fill in the "CME Course Travel Grant Application Form" and send it to the ERA-EDTA Administrative Office (address: ERA-EDTA Administrative Office, Via Spolverini 2, 43100 Parma, Italy) together with a curriculum vitae, a photocopy of a personal ID (passport, ID card, driver's licence) and a signed official letter from the head of department by **May 12, 2006**.

The Grant Winners will receive an official notification from ERA-EDTA Administrative Office and a bank transfer for the amount of EURO 500.00.

After the Grant Winner is informed about this by the ERA-EDTA Administrative Office he/she must send an "Application Form for Membership in the ERA-EDTA" completely filled in to the ERA-EDTA Membership Office (address: ERA-EDTA Membership Office, Via D. Manin 20, 35030 Bastia di Rovolon (PD), Italy). This form can be downloaded from the ERA-EDTA website: go to www.era-edta.org and click on "Membership" from the menu on the left.

Membership in the ERA-EDTA will only start after the ERA-EDTA Membership Office receives the "Application Form", which must be sent no later than one month after the Course. "Applications" received after this dead-line will not be taken into consideration.

d) ERA-EDTA cannot be held responsible for any incorrect information that is given out without its prior written approval or for any Application Forms incorrectly filled in or for any information sent after the dead-line.
